- Department of Housing and Urban Development, Office of Lead Hazard Control and Healthy Homes, *Change is in the Air: An Action Guide for Establishing Smoke-Free Public Housing and Multifamily Properties* (Oct. 2014): The purpose of this guide is to encourage public housing agencies and owners/agents of subsidized or market rate multifamily housing to adopt smoke-free policies. The guide addresses common questions and concerns public housing agencies and owners/agents have about smoke-free policies.

- Tobacco Control Legal Consortium, *Regulating Smoking in Multi-Unit Housing* (Dec. 2013): Series of legal technical assistance to serve as a starting point for organizations interested in implementing certain tobacco control measures. The tips and tools included in this guidance touch upon second hand smoke in the home, policy benefits, and elements of effective policies. It also provides examples of select policies (policies designed for landlords to use to create smoke-free lease provisions and policies that have been adopted in certain locations).
